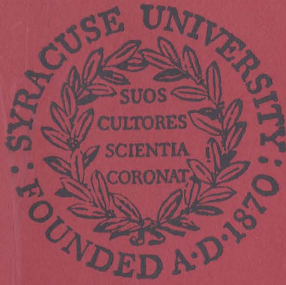

## INTRODUCTION

This Nyanza Province microfilm collection of the Kenya National Archives consists of microfilmed reports and daily correspondence produced by the British colonial administration in the Nyanza Province from 1899 to 1942. The great majority of the records pertain to the period prior to 1930. These documents, filmed by the Archives' technical staff, are arranged, numbered, and filed according to the system outlined in the Provincial and District Catalogs of the Kenya National Archives. This system has been used as the format for the index, and should be used as the key to the filing system when the researcher wishes to consult files pertaining to a particular topic. If the researcher compares the class and sub-class topical references of the filing system listed in the index to the titles and sub-titles listed in the Guide for a particular file, he can acquire a reasonably accurate indication of the file's contents.

The researcher should take note of several details regarding the format of this Guide, and of the files themselves. The file numbers, perhaps the most important information to be found in the list, occur in the upper left-hand corner of each list entry. On the files themselves, these file numbers occur in the lower right-hand corner of the title page. The titles and sub-titles found in the list are the same as those found on the title page of the file. When no title occurs on the title page of the file, the titles and sub-titles in the list have been surmised by perusing the file's contents.

Any such titles have been enclosed in brackets. Although the titles and sub-titles provide a rough guide to the contents of the files, the researcher would be mistaken were he to place too much confidence in them.

The complete Nyanza Province microfilm collection consists of three sections, 10B, 10A, and 10. Section 10B, the first to be filmed, consists of 49 reels. The list for this section has already been published as Occasional Bibliography No. 22 by the Program of Eastern African Studies, Syracuse University (March 1974). The current Guide, to be cited as Occasional Bibliography No. 24, pertains to the 10A collection, which consists of 36 reels. The lists for the third section, Section 10, will be published in two volumes in the near future.

Several persons have made valuable contributions to the preparation of this Guide. Pete Dalleo and Robert Greenstein deserve thanks for their roles in the collection and organization of the Nyanza Province Archives. The list itself was compiled entirely by Alan C. Solomon, whose diligence as Graduate Assistant has contributed much to the success of the microfilm project over the past two years. Special gratitude is also owed to Gloria Katz for her advice and criticism of the list, and for typing the final copy. As with previous indexes to the Kenya Archives microfilms, this Guide was prepared under the supervision of Dr. Robert G. Gregory, Professor of History, and Director of the Microfilm Project.

Finally, acknowledgement is due to the National Science Foundation, whose generous financial support has made both this Guide and the Syracuse University microfilm project possible.
