

Abstract

Taiwan is the first country in Asia to legalize same-sex marriage. This poster briefly introduces the history of Taiwan of legalizing same-sex marriage and points out what need to be done in the future.

Anti-LGBT groups protested with tremendous resources





The government's human rights commission drafted a basic human rights law that included same-sex marriage but not passed. The first pride parade was held.

4 polls showed that more than 50% people in Taiwan SUPPORT same-sex marriages.¹

Enforcement Act of Judicial Yuan Interpretation No. 748⁴

- Married same-sex couples have rights in areas such as taxes, insurance, medical decisions, and child custody.
- Same-sex couples can NOT get married if one comes from the country that does not legalize same-sex marriage.
- Same-sex couples can NOT adopt a child "as a couple" if the child has no blood relationship with one of them.
- **Same-sex couples can NOT use the artificial reproductive** technology in Taiwan to have a baby.

Concerns from Anti-LGBTQ Groups²

1. Same-sex marriage could violate the traditional culture and the meanings of

marriage.


2. Same-sex marriage could seduce people into **being gay**.


3. Same-sex couples could not give birth to children, which could lead humans go extinct.

4. Same-sex families could not provide good parenting.

Constitutional Interpretation No. 748 : Constitutional court rules same-sex marriage prohibition **unconstitutional**. It gave legislative yuan two years to amend existing laws or pass new ones. (25 May 2017)


