RONALD ARONSON is Professor of Humanities in the University Studies/Weekend College Program at Wayne State University. He is the author of *Jean-Paul Sartre: Philosophy in the World* (1980), *The Dialectics of Disaster: A Preface to Hope* (1984), and *Sartre's Second Critique*, which is forthcoming from the University of Chicago Press. He has received fellowships from the National Endowment for the Humanities and the American Council of Learned Societies.

TONY BARTA is a lecturer in History at La Trobe University, Melbourne. His teaching and research interests include the social and political history of Bavaria (in particular the town of Dachau) in the twentieth century, relations between Europeans and Aborigines in Australia, and the role of film and television in historical understanding.

FRANK CHALK is Associate Professor of History at Concordia University in Montreal, Canada. He is chairman of the education committee of the Montreal Holocaust Memorial Center and of the research committee of the League for Human Rights of B'nai B'rith Canada, Eastern Region. His previous publications deal with American foreign policy and African history. He and Kurt Jonassohn teach a course on the history and sociology of genocide at Concordia University and they are working on a book together.

MICHAEL N. DOBKOWSKI is Associate Professor of Religious Studies at Hobart and William Smith Colleges. He is the author of *The Tarnished Dream: The Basis of American Anti-Semitism* (1979) and *The Politics of In-*

difference: A Documentary History of Holocaust Victims in America (1982), and editor, with Isidor Wallimann, of *Towards the Holocaust: The Social and Economic Collapse of the Weimar Republic* (1983).

BARBARA HARFF is Visiting Assistant Professor of Political Science at the University of Colorado at Boulder (1985). She holds a Ph.D. from Northwestern University (1981) and has taught at La Trobe University in Melbourne, Australia, and at Marquette University, Milwaukee. Her research interests are the philosophical and legal foundations of international responses to human rights violations. She is also concerned with the problem of genocide from a comparative and empirical perspective. Her publications include a forthcoming chapter in the *Yearbook of State Violence and State Terrorism*, edited by George Lopez and Michael Stohl, and a monograph, *Genocide and Human Rights: International Legal and Political Issues*, Monograph Series in World Affairs, Graduate School of International Studies, University of Denver.

IRVING LOUIS HOROWITZ is Hannah Arendt Distinguished Professor of Sociology and Political Science at Rutgers University. He has written widely on political sociology and international development and is also editor-in-chief of *Transaction/SOCIETY*, the publication of record in social science and public policy. Among his writings are *Taking Lives: Genocide and State Power* (1980) and *Winners and Losers: Social and Political Polarities in the United States* (1984).

KURT JONASSOHN is Professor of Sociology at Concordia University in Montreal, Canada. He has been secretary-treasurer of the Canadian Sociology and Anthropology Association and executive secretary of the International Sociological Association. He has published in a number of areas. Most recently he has, together with Frank Chalk, been teaching a course on the history and sociology of genocide for several years. They are also collaborating on a book on the same subject.

GERARD J. LIBARIDIAN is the Director of the Zoryan Institute for Contemporary Armenian Research and Documentation and editor of the *Armenian Review*. He has authored a number of articles on the Armenian genocide and is completing graduate studies in history at the University of California at Los Angeles.

ERIC MARKUSEN, M.S.W., Ph.D., is Assistant Professor of Sociology at Old Dominion University in Norfolk, Virginia. He is also a Research Affiliate with the Harvard Nuclear Psychology Program, the Cambridge Hospital, Harvard Medical School and a Research Associate with the Center for Death Education and Research, University of Minnesota. Recent publications include "The Role of Education in Preventing Nuclear War," with

John Harris, in the *Harvard Educational Review*; "The Second Death: Psychological Survival after Nuclear War," with Robert Jay Lifton and Dorothy Austin, in *The Counterfeit Ark: Crisis Relocation for Nuclear War*, edited by J. Leaning and L. Keyes; and *Nuclear Weapons and the Threat of Nuclear War: Critical Issues*, edited with John Harris.

GUNTER W. REMMLING is Professor of Sociology at the Maxwell Graduate School, Syracuse University, New York. He was educated at Worktop College, Notts, England, Bard College, New York, and Berlin's Freie Universität. He has conducted research at the Institute of Political Science, Berlin, in various South American republics, and in Spain. He has contributed articles to many scholarly journals and anthologies of essays. His books include *South American Sociologists* (University of Texas, 1966), *Road to Suspicion* (Appleton-Century-Crofts, 1967), *Wissenssoziologie und Gesellschaftsplanung* (Ruhfus, 1968), *Basic Sociology* (Littlefield, Adams, 1970), *Towards the Sociology of Knowledge* (Routledge and Kegan Paul, 1973), *Der Weg in den Zweifel* (Enke, 1975), *The Sociology of Karl Mannheim* (Routledge and Kegan Paul, 1975), *Hacia la Sociología del Conocimiento* (Fondo de Cultura Económica, 1982), and *La Sociología de Karl Mannheim* (Fondo de Cultura Económica, 1982).

ALAN ROSENBERG is a Lecturer in the Department of Philosophy at Queens College, the City University of New York. He is the author and co-author of a number of articles that appeared in a variety of journals including *Modern Judaism*, *Cross Currents*, *European Judaism*, and *SHOAH*. He is currently writing a book entitled *The Genocidal Universe: A Conceptual Framework for Understanding the Holocaust*, and is under contract with Temple University Press to do an anthology with Gerald Myers entitled *The Holocaust: Its Philosophical Impact*.

JOHN K. ROTH is the Russell K. Pitzer Professor of Philosophy at Claremont McKenna College, where he has taught since 1966. In addition to serving as a Special Advisor to the Chairman of the United States Holocaust Memorial Council, Washington, D.C., he has been Visiting Professor of Holocaust Studies at the University of Haifa, Israel. Presently the book review editor for *Holocaust and Genocide Studies*, Roth is the author of numerous articles on the Holocaust, and he has also published ten books, including *A Consuming Fire: Encounters with Elie Wiesel and the Holocaust*. Co-authored with Richard L. Rubenstein, his most recent book, *Approaches to Auschwitz: The Legacy of the Holocaust*, will appear in 1986.

RICHARD L. RUBENSTEIN is Distinguished Professor of Religion and founder and director of the Center for the Study of Southern Culture and Religion at Florida State University. He is also the author of seven books, including *After Auschwitz*, *The Cunning of History*, *The Age of Triage*, and

The Religious Imagination, for which he was awarded a Portico d'Ottavia Literary Award.

ROGER W. SMITH teaches political theory at the College of William and Mary, where he is a Professor of Government. He was born in Alabama in 1936 and educated at Harvard and the University of California at Berkeley.

ROBERT G.L. WAITE is the Brown Professor of History at Williams College. He is the author of *Vanguard of Nazism: The Free Corps Movement in Postwar Germany, 1918-1923* and *The Psychopathic God: Adolf Hitler*. He has delivered papers on the Holocaust at meetings of the International Scholars' Conference on the Holocaust held in Bloomington, Indiana, and in Tel Aviv.

ISIDOR WALLIMANN studied economics and sociology and holds a Ph.D. in sociology from Syracuse University. At present he is lecturing in sociology at the School of Social Work in Basel, Switzerland. He is the author of *Estrangement: Marx's Conception of Human Nature and the Division of Labor* (Greenwood Press, 1981) and editor (with Michael Dobkowski) of *Towards the Holocaust: The Social and Economic Collapse of the Weimar Republic* (Greenwood Press, 1983). In addition, he is the author or co-author of several articles that have appeared in *Zeitschrift für Soziologie*, *Sociology*, *Australian and New Zealand Journal of Sociology*, *Humanity and Society*, *Youth and Society*, *International Journal of Sociology and Social Policy*, and in other journals and edited works.

WALTER P. ZENNER is Associate Professor of Anthropology at the State University of New York at Albany. The comparison of inter-ethnic relations, with special regard to middleman minorities, has been a central theme of his work. He is co-editor of *Urban Life: Readings in Urban Anthropology* (1980) and *Jewish Societies in the Middle East* (1982), as well as author of *Minorities in the Middle*, due to be published in the near future.
